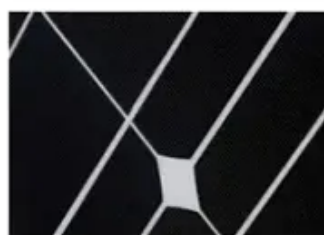
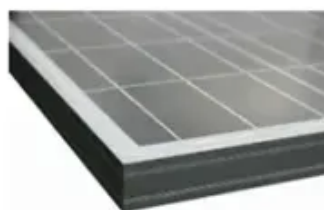

Exports in firm sales with payment of an amount exceeding 200 Tunisian dinars, in respect of products benefiting from the regime of freedom to export, are made without authorization under cover of a definitive invoice domiciled with an approved intermediary, in accordance with the conditions provided by the Central Bank of Tunisia.

How long does a Tunisian import authorization last?

The Ministry responsible for Trade shall keep the Tunisian Central Bank and the Directorate-General of Customs updated on a daily basis of the content of the authorizations granted. The validity of the import authorization is set at 12 months to run from the date of the decision of the Ministry responsible for Trade.

How long does it take to get Customs approval in Tunisia?

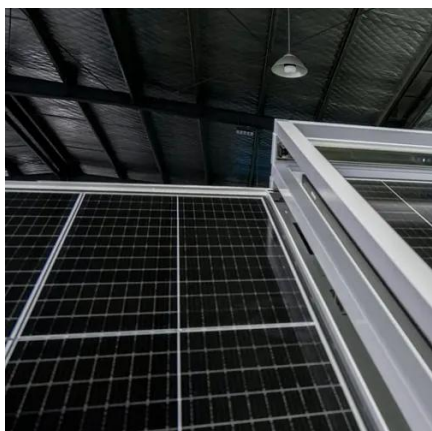
It takes approximately 1 month to be duly approved by both administrations. If shipper is renting the place then Customs will ask for the residence permit, proof of financial resources through the local Tunisian Bank.

What currency can I buy in Tunisia?

Local currency - Tunisian Dinar (TND) - cash import available only with permission. Contact the nearest embassy. Foreigners - the equivalent of TND 5,000. Residents - the equivalent of TND 25,000. Hunting weapons permissible only with authorisation obtainable from Ministry of Interior. Contact nearest embassy for more information.

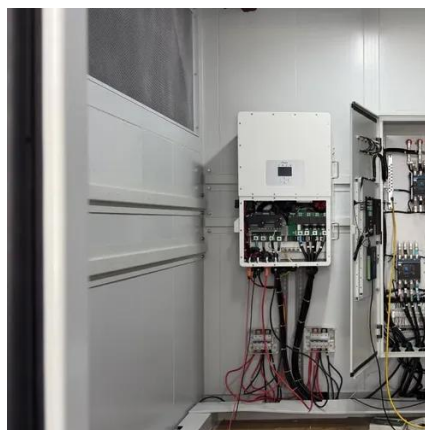
